## Section 4: FIRST AID MEASURES

<b>Necessary First Aid measures:</b>	For advice contact the National Poisons Centre on 0800 POISON (0800 764 766) or a doctor immediately. Begin artificial respiration if the victim is not breathing. <b>Fire Hazard Properties:</b>	As the product contains combustible organic components, fire will produce dense black smoke containing hazardous products of combustion. Exposure to decomposition products may be a hazard to health.
