Chronic / Long Term Effects (Active Ingredient)

Lambda-cyhalothrin technical has been extensively tested on laboratory mammals and in test-tube systems. No evidence of mutagenic, teratogenic or reproductive effects was obtained. Effects of paresthesia (abnormal skin sensation) and neurotoxicity were reversible.

Chlorantraniliprole technical has been extensively tested on laboratory mammals and in test-tube systems. No evidence of carcinogenic, neurotoxic, mutagenic, teratogenic or reproductive effects was obtained.

Environmental Fate

The information provided here is for the active ingredient, **Lambda-cyhalothrin**.

Not persistent in soil or water. Immobile in soil.

Rapidly degraded in soil; DT₅₀ for microbial degradation 23-82 days, for field soil 6-40 days. Strongly adsorbed to soil and sediment organic matter, K_{oc} 330 000. Negligible potential for leaching of lambda-cyhalothrin through soil.

Rapid dissipation from water in aquatic systems. DT₅₀ for dissipation from surface waters in lab water-sediment systems 5-11 hours; in a microcosm DT₅₀ <3 hours. Rapid and extensive degradation of parent compound in aquatic systems; DT₅₀ for degradation in label water-sediment systems 7-15 days; in a microcosm DT₅₀ <3 hours, DT₉₀ < 3 days. K_{ow} logP = 7 (20°C)

The information presented here is for the active ingredient, **chlorantraniliprole**.

Chlorantraniliprole is stable to hydrolysis and is rapidly degraded by photolysis. It is not considered bioaccumulative and is considered not readily biodegradable.

Product Disposal:

Dispose of this product only by using according to the label, or at an approved landfill or other approved facility.
