Section 4: FIRST AID MEASURES

Chronic / Long Term Effects (Active Ingredient)

ISOPYRAZAM technical has been extensively tested on laboratory mammals and in test-tube systems. Did not show mutagenic effects in animal experiments. Increased levels of liver and uterine tumours were observed at high doses in female rats. Animal testing did not show any effects on fertility. Evidence of developmental toxicity (reduction of foetal weight) and embryoletality in rabbits.
